In addition, your child may be seen by a Pediatric fellow, Pediatric resident or medical student.

Please make your primary care physician aware of this appointment. On the day of your appointment, please bring your completed history form (attached) and your medical coverage cards. All patients are weighed and measured at this visit. Please continue with your usual meals and fluid intake. Please arrive at least 15 minutes before your appointment time. We appreciate you taking the time to register early, and we will make every effort to keep the clinic on schedule.

The Registration Desk is located in Suite 304A.

### **WHAT TO EXPECT DURING THE VISIT**

The initial visit may last 2-3 hours, so please plan accordingly. Your child's history will be discussed and an examination will be performed. Blood work and an EKG will be done at the visit. Any additional diagnostic studies and a nutritional evaluation will be done at the next appointment.

**Until your child is an established patient, please refer questions and concerns to his or her primary care doctor.**

Lab results will be reviewed at the next appointment. If anything needs to be addressed prior to that visit, we will contact you by phone.

### **INSURANCE AUTHORIZATION**

### **CANCELLATION POLICY**

To cancel a new patient appointment, call 401-444-4712 *at least 48 hours* prior to the appointment date so we may give the appointment to a patient on our waiting list.

### **DIRECTIONS TO THE CORO CENTER**

#### **From the North:**

When traveling south on I-95, take exit 19. At the end of the ramp take a left on to Eddy Street and proceed to the stop light at the intersection of Eddy and Point Streets (landmarks include a gas station, and Davol Square).

Turn left onto Point Street. Proceed up Point Street until you see the Coro West building on your right. Turn right onto Hoppin Street. The Coro Center (west building) is located on the corner of Point and Hoppin streets. Bear right onto Bassett Street, right on Clifford Street, then left into the Coro garage and take a ticket. Bring your parking ticket in for validation.

#### **From the South:**

When traveling north on I-95, take exit 20 (Point Street). At the stop light, you will see the Coro Center (One Hoppin Street). Proceed straight ahead, turn right onto Bassett Street, right on Clifford Street, then left into the garage and take a ticket. Bring your parking ticket in for validation.

#### **From the East:**

Take I-195 West to I-95 North. Take Exit 1A (Point Street). At the stop light, you will see the Coro Center (One Hoppin Street). Proceed straight ahead, turn right onto Bassett Street, right on Clifford Street, then left into the garage and take a ticket. Bring your parking ticket in for validation.
