# **Training & Qualifications for Advanced Practitioners:**

## Nurse Practitioner Requirements:

- Earn Master's degree or doctoral program
- Receive advanced clinical training beyond the initial professional registered nurse preparation
- Enter practice with 6-plus years of postsecondary education and clinical preparation
- Undergo rigorous national certification process
- Adhere to a code of ethical practices
- Earn license in all 50 states, and the District of Columbia



## Physician Assistant Requirements:

- Complete education in accredited graduate-level Physician Assistant programs
- Receive training in medical and behavioral sciences
- Do rotations in internal medicine, family medicine, surgery, pediatrics, obstetrics and gynecology, emergency medicine and geriatric medicine.
- Undergo rigorous national certification exam on diagnosing and treating complex medical issues
- Pass a recertification exam every 6-10 years
- Earn license in all 50 states, and the District of Columbia
