PGY1 Pharmacy Residency

The Residency

The Coastal Medical/URI residency is a unique 12-month PGY1 residency providing direct patient care in outpatient primary care practices. The resident works collaboratively as a member of the healthcare team to prevent and alleviate medication-related problems, optimize patient outcomes, advance the workflows for medication use and safety in primary care, and evaluate the impact of medication management services. The resident will receive training in the delivery of direct patient care, the enhancement of professional communication and interpersonal skills, academic teaching, student precepting and management skills. Clinical experiences may include adult internal medicine, diabetes, cardiology, pulmonology, smoking cessation and pain management. The resident will have the opportunity to complete a medication class review and provide drug information services while on rotation at the URI Drug Information Services.

Our student precepting environment allows residents to develop strong teaching skills. Our capable research staff is an excellent resource for assisting the resident in developing a solid foundation in research design and analysis.

The resident will meet quarterly with the residency program director to tailor the resident's schedule to meet individual goals. Upon completion of the program, the resident will be awarded an ASHP accredited residency certificate if all program requirements are met.

Benefits

- 1-year stipend in the total amount of \$53,000
- Eligible for Coastal Medical health insurance coverage
- 10 vacation days and 5 sick days
- Travel reimbursement to present a research project at a clinical meeting
- A dedicated workspace and a laptop computer

Qualifications

Qualifications for participation in the Coastal Medical/URI PGY1 Residency Program are in accordance with the criteria set forth by the American Society of Health System Pharmacists (ASHP). Residents shall be: graduates of an Accreditation Council for Pharmacy Education (ACPE) accredited Doctor of Pharmacy degree program; licensed or eligible for licensure in RI; and participate in and obey the rules of the Residency Matching Program.

Pharmacy Services

Pharmacists are a part of Coastal Medical's population health strategy and are integral members of our care management programs. Pharmacists work under a collaborative practice agreement and provide services to all of the adult internal medicine practices and family medicine practices.

Services include:

- Chronic disease state management via in office visits or telephonic outreach
- Opioid and antibiotic stewardship services
- Comprehensive medication reviews for targeted patients
- Anticoagulation management
- Drug information services
- Medication adherence and quality services
- Participation in multidisciplinary care conferences

Pharmacy Program Structure

In the pharmacy program, pharmacists have several unique roles, including role-based pharmacists, population health management pharmacists, and a managed care pharmacist.

- **Role based pharmacists**
 - Assigned to a pharmacy service depending on the day of the week to provide clinical pharmacy services such as drug information, in person and telephonic patient education and anticoagulation management
- **Population health management pharmacists**
 - Provides services to patients via the diabetes management program, heart failure program, chronic obstructive pulmonary disease (COPD) program, and more
- **Managed care pharmacists**
 - Works with payers to meet all medication-related quality measures and outcomes
 - Supervises the pharmacy technician team, monitors patient adherence and provides services to improve medication access and lower medication costs

All pharmacists also participate in the education and training of advanced pharmacy practice experience (APPE) students from the University of Rhode Island.
